

# Program Overview Brief Grant Assistance Program

**SUBMIT:** Your team or designated point of contact must submit the grant application so you are the final point of contact in the grant submission chain. Grayshift will not submit grants on your behalf.

#### YOUR REQUIREMENTS:

- Identify a dedicated point of contact from your agency to work with the Grayshift grant writer
- Ensure your agency registers with Gov.com and Grants.com
- Provide your agency's UEI (DUNS), SAM, and Tax ID numbers
- Confirm that your agency is not delinquent on any federal accounts or funding
- Disclose required information for any current grants
- Work alongside the Grayshift grant writer to review and complete your grant application
- Submit your finalized grant application
